Organisation's structure and our supply chains

We are a credit reference agency and provider of company credit reports and market information, supplying quality data on over 240 million companies to 90,000 customers around the globe. We are part of the Creditsafe Group and our ultimate parent company is Safe Information Group NV, registered in the Netherlands and privately owned. Creditsafe Group operates from a shared service centre in Cardiff Bay, UK to provide marketing, finance, legal, IT development and support services across the operating companies. The Group has over 1,000 employees worldwide and operates in Europe, America and Asia, with subsidiaries established in the United Kingdom, USA, Germany, France, Italy, Ireland, Belgium, Sweden, and the Netherlands. We opened our latest business in Japan in September 2016.


Training
